#### 573. CIL Committee

Cllr Phipps provided a verbal update on the recommendations to Council from the last meeting attended by LP & PR and subsequently approved by JaWa, including

- A bench at the Children's section of Bedwas Cemetery
- · Wildflower planting in the BTM area

CCBC approval has already been given. Cllr Phipps willing to liaise with CCBC contractors regarding installation. This was <u>AGREED</u>.

### 574. Environmental & Leisure Matters

574.1 It was <u>AGREED</u> that the following events for 2020-2021 are to be cancelled as a result of the Covid Pandemic

574.3 Macmillan Coffee Morning. BTMCC have previously taken responsibility for putting on a coffee morning in this area. It is due to be held in the Trethomas area this year. The proposed venue is potentially no longer available. Concerns were raised by Cllr Aldworth regarding inviting people to a gathering and being able to adhere to Covid restrictions. Therefore, the BTM CC event may not be able to take place this year and she suggested a donation in lieu could be made to MacMillan. The Chair invited members to agree now or defer to the October meeting. He advised he was willing to donate £200 from the Chair's fund. Cllr Phipps informed Members she intends to support the coffee morning at the Church House Inn on September 25<sup>th</sup> as they have Covid procedures in place, and proposed that the Chair's cheque could be presented at this event. It was AGREED that a donation of £200 from the Chairs fund made out to Macmillan in lieu of the BTM CC Coffee Morning would be given.

574.2 Memorial bench at Bryn Park. Cllr Phipps has been contacted by the manager of the Spar in Trethomas, who have raised £1050 from the community towards a new bench for Bryn Park. There is shortfall for the total cost and installation of £622.80. It was AGREED that BTM CC would meet this cost from the CIL

### 576. Land & Buildings Committee

Cllr McConnell provided a verbal update. The most urgent issue is the ingress of water at the Bedwas Workmen's Hall flat roof, which now needs replacing. The Clerk and Caretaker have tried over several months to obtain quotes from several companies. To date, only one received. The matter is now becoming urgent with the approach of winter as there will be further deterioration and will cause additional issues at the hall. It was noted that it is the landlord's responsibility to undertake the necessary repairs to ensure health and safety and to allow the hall to continue to operate. It was AGREED that an additional company should be approached, but if no further quotes are received there would be no alternative but to accept the current quote.

577.8 Publicity and consultation before applying for planning permission 14th July 2020 from asbri planning. Motion submitted by Cllr Llewellyn was unable to be taken forward as no seconder received. The Members are aware of the feelings of the local community on this issue. Cllr Havard provided a statement on behalf of the Labour party on this matter. See appendix 1. Cllr Havard stated that this statement by Labour is not to be shared on Facebook by Cllr Llewellyn, but should he wish to do so, Cllr Havard would consider legal action against him if it is not factually correct. He expressed his feeling that Facebook is not the correct medium for this debate, as any fight will be done by the Community Council working together using the correct channels. Cllr Llewellyn stated that Cllr Havard had made this political. He responded by saying that Cllr Llewellyn had already made this political by his actions on Facebook. Cllr Llewellyn stated arguments on Facebook should not be taken into the full Council meeting and noted his disappointment with the remarks made by Cllr Havard. Cllr Winslade noted her disagreement with having disputes on Facebook between Councillors as this is inappropriate and highlighted that all Councillors work hard for the community in different ways. The Chair reminded all Councillors of be mindful of their actions.

It was highlighted that this is currently in the consultation stage, and therefore Councillors will respond to an application, as appropriate, if and when received by CCBC planning department as they do not wish to detrimentally pre-empt any final application and the planning process.

## Appendix 1

The verbal statement provided by Cllr Havard, Deputy leader of the BTM Labour party, at the BTM CC Council meeting on 27<sup>th</sup> August 2020

'As (Labour) members of this (BTM) Community Council, we are always very conscious of the need to protect and enhance our local environment and have demonstrated this belief in the many actions we have taken in our brief, but honourable, history. As a Labour group we have never shied away from the fight, and we don't intend to do so now. This is not getting prepared for an election year for us, as it is for some, but it is about our principles. Elections come and go. but the people we represent expect our full support all times.

At the moment we are facing a proposal that we believe is not wanted by the public so, once a formal proposal is deposited with CCBC we will consider its ramifications and possible damage to our Village. This is what we have always done, and we have never been shy of telling authority and Developers what we think. We have stopped or modified some Proposals but this is a process fraught with many difficulties because the truth is that planning laws usually work in favour of the Developer- but that won't stop us fighting - it never has. We did have one great victory some years ago, when we stopped (CCBC Council controlled by) Plaid Cymru's attempt to put a dump in the middle of Trethomas. That was a difficult one but we won that. At this moment there is no application in CCBC Planning Office. If or when it arrives. we, in the Labour Group will be first, as usual, into the fight'
