#### Audit opinion - Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use
  of resources.

#### **Basis for Qualification**

#### **Accounting Statement**

In my opinion, the Accounting Statement has not been prepared in accordance with proper practice and does not properly present the Council's receipts and payments and financial position:

- The accounts are prepared on a receipts and payments basis. However, the Council has included as a receipt £3,709
   VAT that was not received until after 31 March 2021
- Lines 3, 7, 9 and 11 are therefore overstated by £3,709

I am unable to conclude whether or not the accounts have been approved by the Council as required by the Accounts and Audit (Wales) Regulations 2014.
