Expenditure under \$137 Local Government Act 1972 and \$2 Local Government Act 2000  Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.  In 2021-22, the Council made payments totalling £ 16, 403 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

#### **Auditor General's report**

#### Audit opinion - Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use
  of resources.

#### **Basis for Qualification**

#### **Accounting Statement**

We note that the comparative figures contain the following material errors:

- The arithmetic for lines 1-6 does not equal the balance carried forward figure (line 7)
- The stated line 7 figure does not equal line 11 within the statement of balances.
- A debtor balance is within the annual return, however the Council is preparing the accounts on a receipts and payments basis and therefore should not include a debtors balance.

We also note that the accounting statement has been restated without the relevant disclosures.

The current accounting statement includes Community Infrastructure Levy (CIL) income received by the Council totalling £53,375 within line 2 of the statement of receipts and payments. The correct treatment would be to include income received from CIL within line 3.

#### **Annual Governance Statement**

In my opinion, the Annual Governance Statement is inconsistent with the Council's governance arrangements for the year

• Assertion 6 – adequate effective system of internal audit. The Council's internal audit report per the annual return is inconsistent with the Annual Governance Statement and the full internal audit report issued to the Council on 01 May 2022. The full internal audit report states there are no issues to report which contradicts with the negative responses to part 9 and 10 of the annual internal audit report within the annual return.
